Namibia adopted the **"National Development Plan"** as a strategic tool for transforming society and uplifting the standard of living of the Namibian people

The Vision 2030 implemented through national development frameworks (NDPs and recently HPPs.)


NDP5 (2017/18-2021/22) ended in March 2022 – *extended to March* 2025

INTRODUCTION Cont...




- Cabinet approved the development of NDP6 and to cover 2025/2026 - 2030/31 FY to allow for the completion of HPPII implementation period.
- the focus for 2023/24 to 2024/25 is therefore on HPPII programs/projects and NDP5 ongoing projects.
- NDP6 formulation process launched in June 2023
- NDP6 is a **final "leg"** in the journey towards realizing Vision 2030.


Planning Framework in Namibia

DP 6 development planning process





Integration of M&E into the National Planning Framework

- Over the past NDP's, M&E was found to be weak and inconsistent with no clearly defined M&E tools, hence the need to develop an M&E plan for future NDPs, starting with NDP6.
- The aim of the National M&E Plan is to monitor and evaluate progress made towards goals and outcomes and against indicators and targets as stipulated in the NDP6.
- It describes how you will monitor and evaluate your program, as well as how you intend to use evaluation data for project improvement and decision making.
- The component of an M&E Plan includes theory of change, logic model, result framework, indicators, data management plan and reporting.

M&E Process for NDP6

1. Identification and consultation with stakeholders

4. Reporting:

(O/M/As to report on quarterly basis, NPC to produce biannual report for cabinet) 2. Development and approval of an M&E Plan (intervention logic, indicators and setting of targets)

3. Integration of the national NDP6 M&E plan into institutional plans (Strategic and Annual plans)
