NANASO is a national umbrella body of non-governmental organisations (NGOs) providing network services to member organisations active in the field of HIVa and AIDS, Tuberculosis (TB) and other emerging epidemics/pandemics.

NANASO's aim is to strenghten its member organisations to maximise their potential in order to effectively respond to these diseases and related health concerns in Namibia, and to act as their advocacy mouthpiece on matters of common interest.

NANASO was established as a Welfare Organization in 1991 at the "summit" of HIV in Namibia.



Primary goals

To influence strategic policy and support structural linkages to leverage on shared responsibility toward epidemic control

To shape the narrative on the disease evolution to reduce legal and structural barriers that fuel stigma and discrimination

To fortify the capacity of members on strategic programmatic and financial management as well improve their visibility

- Advocacy and lobbying for members in the corridor of power

- Development of new policies such as the HIV COVID 19 NCES

Challenges



- Members autonomy vs network, a complex balancing Act
- Shifting funding landscape
- Donor's rigid requirements premised on top-down approach
- Balancing urban and rural dynamics representation in community engagement
- Unifying the diverse voices and interests
- Legal literacy and epidemiological context for members
- Coordination is not a prioritized function in the funding scope
